**DISCOUNTS:** Your standard Afina discount also applies to Timeless Traditionals Wall Mirrors.

**TERMS AND CONDITIONS:** 1% 10 days/net 30 days with approved credit. A service charge of 2% (24% annual rate) will be added to all past due invoices. Plus any, but not limited to, professional, legal and/or collection fees incurred.

**FREIGHT:** All orders shipped, F.O.B. Paterson, New Jersey 07501.

**CONDITIONS OF PURCHASE:** Orders are accepted subject to strikes, fires or other conditions beyond our control. Final approval of orders is subject to factory acceptance, including orders given to our representatives.

Shipments are packaged in approved containers. Claims for merchandise damaged or lost in transit should be filed with the delivering carrier immediately. \*Claims for shortage must be made in writing within five (5) days of receipt.

No return items accepted without prior return authorization(RGA) from the factory. All returned merchandise (if approved) subject to 30% restocking fee, plus freight in/out.

Product descriptions, prices and specifications contained in the price list, corresponding published literature and catalogs were in effect at the time of publication. We reserve the right to discontinue products at any time, or change prices, specifications and/or designs without prior notice. This current price list supersedes all previous price lists.

**LIMITED WARRANTY:** Afina warrants to the original purchaser that, it will repair without charge, products made by this company shown to have significant defects in material or workmanship which are reported to Afina in writing within one (1) year from the date of delivery. Warranty of mirrored products subject to trade practices and policies of the National Association of Mirror Manufacturers. A three (3) year guarantee on all mirrors against defects.

The warranty is void in the event the product is damaged in transit, or if damage or failure is caused by abuse, misuse, abnormal usage, faulty installation, damaged in an accident, improper maintenance, or any repairs other than those authorized by Afina. At the expiration of the year warranty period Afina shall be under no further obligation under any warranty, expressed or implied, including the implied warranty of merchantability.

Afina shall not be liable for any consequential damages arising out of or in connection with the use or performance of its products. Some states do not allow limitations on how long an implied warranty lasts or do not allow exclusion or limitations of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

Any liability against Afina under any implied warranty, including the warranty of merchantability, is expressly limited to the terms of this warranty.

Permission to return any merchandise under this warranty must be authorized in writing (RGA) by the factory and returned prepaid by the customer.

Claims under this warranty should be sent directly to the dealer.
